### Highlights of the 78th LWVD Annual Meeting - Saturday, April 30 at 9:00 AM

One focus of the 78th LWVD Annual Meeting will include completing the steps to becoming a 501(c)(3) non-profit organization. The first step will be to review, discuss and vote on the new bylaws that will govern our organization. Linda Wassenich will provide you with a synopsis of the changes and walk you through the process.

Pending bylaws approval, we will then vote to move all of our members and all of the funds from the old League of Women Voters of Texas Dallas (yes, that was the official name of our organization) into our newly named League of Women Voters of Dallas.

We will also vote on basic bylaws for the 501(c)(4) shell organization that we will maintain as a safe guard. This organization will not be a membership organization, nor will it have any funds, but it can be funded in a pinch. Many of the large Leagues that have converted to a nonprofit have established an inactive 501(c)(4) shell, but none have ever used it. We will then discuss the

amended Articles of Incorporation.

Treasurer Sandy Thornton and budget chair and President-Elect Cecilia McKay will explain how we will transition to a fiscal year that begins June 1, coinciding with when our officers become official. The new budget will be voted on. We will review our current investments and our strategic plan.

Nominating Committee Chair Pat Vaughan will present the Nominating Committee Report and LWVD members will elect new officers.

Awards will be presented to those who have made significant contributions to the League and to new 50year Members.

Board Vice Presidents will give reports, and the Development Chair and the Susan B. Anthony Luncheon Chair will review our development success and plans for the future.

As Vice President for Voter Outreach with the Dallas League of Women Voters she strives to see that League signature outputs get done.

Thanks to the unfailing support of the League and legions of other volunteers who also share the desire to "make democracy work", things such as the Voters Guide, Vote411, the Your Elected Officials pamphlet and voter registration are maintained. In addition, she undertakes projects designed to address one of the most urgent issues of our time, poor voter turnout. This year's project involves working with LULAC to improve the voter participation of young Latinos.

Bill Betzen, Virginia Macdonald Leadership Awardee, was born into a large extended family and grew up on a farm eight miles north of Hereford, Texas. He graduated from the University of Dallas and worked for 17 years as a Dallas County child abuse investigator where he was a supervisor of an investigative unit in Dallas for a decade. He then

worked with Lutheran and Catholic social service agencies focusing on the pioneering of open adoption alternatives in Dallas.

Bill finished his professional career by joining his wife in teaching. He worked in a Dallas ISD middle school where he helped develop a dropout prevention projectthe School Time-Capsule Project. He retired to help spread the project. He now volunteers with 11 Dallas ISD schools that have an active Time-Capsule Project and is now preparing the second 10-year class reunion. This time it is for the students who wrote letters to themselves in 2006 as 8th graders.

He joined the League of Women Voters in 2012 and has been a board member involved in the Education Committee since 2013.

Bill and his wife Carolyn have raised two boys and two girls over the past 35 years and are now blessed with six grandchildren.

#### LWV March Unit Meetings Wrap-Up on Public Education in Dallas

The four March unit meeting presentations were an update on Dallas Independent School District's traditional public schools and public charter schools.

Texas started independent school districts in the early 1900s as a type of school district for primary and secondary education. They are an entity that is independent and separate from any municipality, county, or state. The objective was to keep city politics out of the administration of public schools. The democratic process was followed by electing the school board or trustees.

Charter schools were authorized in 1995 by the Texas Legislature. Proponents argued that charter schools could do a better job than ISDs at less cost. Charter schools are publicly funded, independent schools established by teachers, parents, or community groups under the terms of a charter with a local or national authority. Charter school's have boards of directors or boards of trustees appointed by the Charter Management Organization or founder, if there is no CMO. Parents cannot change the practices in a school. Their only choice is to stay or leave.

A quick overview of League education positions at national, state, and local levels was presented including the LWV US privatization position. The other positions used in determining League action are the best use of public money, the principles of democracy for parents to select the schools' leadership, what is taught, and how their children are taught.

The four main aspects of education used to compare the two systems were achievement or performance rates, cost per child, graduation rates, and the public money from the Texas State budget to fund both systems. The data used was provided mainly by Dallas Independent School District (DISD) and the Texas Education Agency (TEA).

Student performance, reported in the Snapshot 2014 reports on the TEA web site, states that academic performance in charters was below ISD's in Texas. The cost per child for total operating expenditures per student were \$195 higher in charter schools than in ISD's. Both ISD and charter schools get more per child for special needs children.

The presentation illustrated the effect of many charter schools in close proximity. DISD bond elections and annual budgets have not shown equity in maintaining district schools.

## Mobilizing Dallas to Bring Significant Changes to Predatory Lending Practices

This past year, the League of Women Voters of Texas explored payday and auto title lending in Texas from all viewpoints - history, stakeholders, use, policy options, and approaches to reform. In January 2016, the League adopted the following position:

The League believes that a loan is affordable if the borrower can repay the loan and cover basic expenses without borrowing again or obtaining money from another source. Local governments should be able to regulate payday and auto title lending within their jurisdictions in order to achieve a viable small dollar loan market that provides consumer access to affordable credit and safeguards against predatory lending.

The Anti-Poverty Coalition of Greater Dallas (APC) strives to unite the entire community around identifying and eliminating barriers preventing families from moving out of poverty and into financial sufficiency. One focus has been predatory lending and how best to protect vulnerable individuals. APC led the effort in the City of Dallas to pass ordinances that provide guidance as to where lenders can be located and how loans are structured.

At the Federal level, the Consumer Financial Protection Bureau (CFPB) is about to release new rules regulating these lenders. The APC wants to make sure that the Dallas area continues to be a leader in the fight by spreading awareness on the need for these rules. This could be the one chance to get

comprehensive payday reform, so we need to make sure the CFPB and Congress know these rules are necessary.


At the May 5th APC meeting, you will hear how you can help raise attention to the need for increased regulations and why your voice is so important to the fight for reform. A lot can be accomplished if every person commits to talking about this and encourages as many people as possible to submit a comment in support of the rules. APC's goal is to get over 1,000 people from the Dallas area to submit a comment.

Also, if the CFPB has released the rules by then (as is rumored), an overview of the new rules and how they will protect consumers will be given.

### **Primary Election 2016**

Dallas County turned out for the primary election on March 1. This election saw the best turnout for more than a decade for a primary election, with the exception of the stunning high in 2008. Below is a chart tracing turnout in primaries and the general election since 2004.



While it was encouraging to see good turnout, there were still reports from around the county of people having difficulty finding their polling place.

Don't forget! The primary isn't over until the runoff. A number of contests will be decided in the primary runoff on Tuesday, May 24, including Democratic contests for Railroad Commissioner, Dallas County Tax Assessor-Collector, a Republican contest for Sheriff, and judgeships both local and statewide.

Additionally, on **Saturday, May 7**, we vote in local elections for school board members, city council members and Dallas County Community College District board members.

I hope to see all of you at the polls this May!

#### KOREAN "COMFORT WOMEN" TO SPEAK AT SMU

In our study on Human Trafficking, we learned about the current prevalence of sex trafficking. During World War II, Korean women were taken as sex slaves for Japanese soldiers. They are now in their 90s and are telling their story through a book and a film, Spirits' Homecoming.

#### **LWV Texas 2016 Convention Review**

LWV Texas President Elaine Wiant ably opened and conducted the 2016 LWV Texas convention in Houston March 11-13. Attending from Dallas were Susybelle Gosslee, Cecilia McKay and Eileen Rosenblum. They were part of the 97 delegates who participated in a variety of meetings and events planned for the weekend. The theme of the conference was: *Celebrating the Past*, *Embracing the Future*.

Chair Chris Davis Garcia and other members of the Texas Convention Committee earned kudos from attendees on every level for an outstanding and informative convention.

The evening river cruise of the Houston ship channel was a beautiful opening event with wonderful food, a fascinating shoreline and great conversation. A great slate of new officers was elected without opposition, and the biennium budget was approved.

The conference began for Cecilia and Eileen with an 8:30–11:30 AM Friday meeting related to their participation in Membership, Leadership Development (MLD). Participants in the meeting were asked to share ideas for developing leaders. The take-away from the session was that someone must ask a potential leader to take a leadership position and then to assume a position on the local board.

Friday was devoted to workshops and an entertaining lunch that included a fashion show highlighting fashions that suffragists wore during their battle for the vote. In addition Jennifer M. Ross-Nazzal, NASA historian and author, spoke about her book *Winning The West For Women: The Life of Suffragist Emma Smith DeVoe*.

LWVUS President Elisabeth McNamara engaged League members with news of the national, state and local Leagues' successful operations while reminding us that *the vote is a symbol of equality* and *the League protects and serves the voters*. She noted that League work calls for us to build relationships and become more grassroots and noted the League's generation of informed citizen participation in the political discourse. Elisabeth will be resigning her position as LWVUS President in June. She announced that the National Convention in Washington DC will begin with Lobby Days on June 16 through Sunday morning, June 19.

Laura Blackburn, LWVTX Advocacy VP, reported instrumental efforts on Texas legislation to protect the vote, the public, and the environment. Local League members are needed to make more calls and emails for the LWV to be more successful. Susybelle Gosslee participated in a panel discussion on Advocacy discussing advocacy at the local level. Dallas Leaguers Elaine Wiant will remain President and Miriam Foshay will remain Treasurer of LWV Texas.

The President's Award went to Janice Schieffer (Plano) for her work with the LWV US, Texas and Plano Boards. Patti Jantho's (Plano) fabulous production, *We Hold These Truths*, was creatively performed by LWV Collin County and (former Dallas Leaguer) Mary Overton of LWV Austin.

The resolutions by passionate League members to promote human rights and democratic empowerment had unanimous support.

The new state program recommended by LWV Texas was *Get-Out-The-Vote: New Action.* The goal is to encourage informed and active participation in government by facilitating voter engagement. The objective is to increase voter turnout in Texas by 5% from 2012-2020. You can find more details about this on the LWVTX website. Other details about the convention and program will be forthcoming from LWVTX.
