TO GIVE OR NOT TO GIVE—501(c)(3)

At the January 13 & 14 Unit Meetings we will discuss the idea of converting our LWVD organization from its 501(c)(4) status to a 501(c)(3) organization and take a 501(h) election. The 501(h) election allows an organization to allocate up to 20% of its expenditures to lobbying.

- Within the 20%, one-fourth (5% of total) can be spent on grassroots lobbying, which involves notifying members and/or urging the public to take action about a specific bill or regulation.

- No more than three-quarters of the 20% (15% of total) can be spent on direct lobbying, which is contacting elected officials and/or executive branch officials for or against a proposed bill, regulation or official action.

Since the League has had two organizations for many years, donors have had to decide whether to give to the Education Fund and take a tax deduction or give to LWV

Dallas, which is not tax deductible. A key factor in making this decision is whether you itemize your deductions on your tax return.

If you take the standard deduction and do not itemize, contributions to LWVD, 501(c)(4) are always appreciated. If you itemize your deductions on your tax return, then a contribution to LWV Dallas Education Fund allows you to deduct this contribution from your total taxable income.

While people do not generally make contributions solely for the purpose of getting a tax deduction, deductibility may figure into deciding the size of your contribution. This information is pertinent to other organizations that have a 501(c)(4) side and a 501(c)(3) side; while you may not need it for your donations to the League, it is good information to know.

MEDIA NOTE: Elimination of Passport Visa Pages

The U.S. Department of State will no longer add visa pages into U.S. passports beginning **January 1, 2016**. Previously, U.S. passport holders had the option to pay for the insertion of additional 24-page visa inserts when valid passports lacked adequate space for entry or exit visa stamps. The decision to discontinue this service was made to enhance the security of the passport and to abide by international passport standards.

To mitigate the impact on frequent travelers, the Department began issuing 52-page passports to all applicants outside the United States starting October 1,

2014 for no additional cost. Applicants within the United States may choose a 28-page or 52-page book.

Requests for additional 24-page visa inserts will only be accepted until December 31, 2015. Beginning January 1, 2016, applicants in need of additional pages in their valid passports must obtain a new passport by mail.

EDUCATION UPDATES



GOOD NEWS at DISD Board Meeting on November 19, 2015

At the Dallas ISD Board meeting on 11-19-15 I gave a report that is also viewable in *Item 5* of the meeting video at <http://www.dallasisd.org/Page/35467>. It is about some very positive observations.

I spoke about events from the previous Tuesday, 11-17-15, when 11 schools were visited that have active **School Time-Capsule Projects**. Six of these 11 schools were among the 56 improvement plan schools that the DISD School Board was considering that day for the most severely failing schools in DISD. These 11 **Time-Capsule Project** schools are Pinkston, SOC, and Sunset and all the middle schools feeding into them, plus Atwell and Browne middle schools.

I spoke of going to these schools that Tuesday to take photos of the shelves inside each vault, each time-capsule. The goal was to record the number of shelves in each vault that are now filled with hundreds of letters - each from students to themselves about their futures. A graduate student from the UNT Dallas Master's Program

was with me. She is considering a master's thesis on this system of student motivation. Visiting these schools is normal, and I had not visited some in almost a year.

But, that Tuesday things were very different! The schools were very quiet as we walked the hallways to each time-capsule vault! The graduate student noticed the same thing. People were whispering in the hallway, and it was NOT a testing day! That level of quiet was not normal. At Edison I even asked if students were in school that day it was so quiet.

I congratulated Dr. Hinojosa at the November 19th board meeting. It was obvious from these 11 visits two days earlier that something had changed within DISD. If all DISD schools are this quiet, and students are not walking in the hallway during class, then progress is being made!

I hope that that quiet Tuesday in November was the new normal for DISD. **DISD is making progress once again!**

DISD BOND and South Oak Cliff High School: An Example of Needs at DISD Schools

After parents met with Superintendent Mike Hinojosa to discuss poor conditions in South Oak Cliff High School, the students decided to deliver a message of their own. They had their own press conference on Monday, December 7, at 2 p.m. after taking the STAAR test.

The superintendent heard the complaints of parents and students that Monday evening. They peacefully reported that often there was a bad smell in the building, and it hindered study and concentration. Two weeks earlier the building had a gas leak. Classes continue to be held in the hall, because the classrooms are either too hot or too cold. The roof has leaked since last spring causing some classrooms to be unusable during rain

storms. One student had ceiling tiles fall on her head during class. There is not enough janitorial service in the building. The school building has not been updated in so long that it still has chalk boards which create a fine dust that the children breathe.

Last spring, the air conditioning stopped working so the students had to take their classes and tests in the heat. They were told that repairs would be made during the summer before they returned for the fall semester; however, they arrived at school in August to find that the repairs had not been made. The semester started off hot, but now it is cold as there is no heat.

(continued) **DISD BOND and South Oak Cliff High School** There are not enough teachers, especially accredited teachers, assigned to the school so substitutes are placed in the classrooms. The substitutes have no lesson plans or grades for the students. South Oak Cliff High School students like their current principal, but that position has been unstable due to new principals being assigned every year.

Other schools in the feeder pattern reported their problems. One elementary school had to stop serving breakfast to the students in the classrooms, because rats were so prolific in the school. Staff was told by the elementary school teachers and principal that serving breakfast in the classroom would not work, but the breakfasts continued to be served in the classrooms.

No school in north Dallas has reported problems like these.

Superintendent Hinojosa explained that \$13 million worth of needs for South Oak Cliff High School have been identified by the Future Facilities Task Force. However, there is no guarantee in this bond program that South Oak Cliff High School will get the repairs made or how soon. Further research revealed that the 2008 DISD Bond Program had South Oak Cliff High School listed as to have received a replacement of the boiler and the chiller. The air conditioning systems pipes above the halls are so leaky that they need to be replaced. Research will continue to determine if the equipment was installed.

Superintendent Hinojosa said that he had learned much that he did not know about South Oak Cliff High and was concerned. He said, "The worst is not over---hope is coming." There are many old schools with many problems and the issues are complex. Hinojosa said that the team will work on it.

POLLUTION IN DALLAS CAN BE CHANGED

Pollution is devastating in Dallas and the world, but we continue to pollute. In 1992, the U.N. had its first significant climate summit. The global concentration of carbon dioxide in the atmosphere was just above 350 parts per million. This year, the global measurement of the concentration of carbon dioxide in the atmosphere averages more than 400 parts per million. The International Energy Agency recently reported that the energy sector emitted as much carbon dioxide over the last 27 years as all the previous years combined.

Climate change is beginning to wake people up. The scientists tell us what we must do, the engineers tell us how we can do it, and the activists push to make the possibilities a reality. We've seen Hurricane Sandy in the northeastern US, Typhoon Haiyan in the Philippines (which killed more than 6,000 people), heat waves, freak

snowstorms, drought, and fire across the dry American West and across Australia, unprecedented flash floods and deluging rains, and endless broken temperature records.

One question is "Who has the power to create the changes needed to create sustainability?" The answer is that WE DO. We have the power as individuals and as an organization. We have the power by being informed, by changing the way we live to be more sustainable, and by changing the way we vote when we vote for candidates who support a clean environment.
