The Voter

Voting rights still not secure

August 18 marked the 97th anniversary of the ratification of the 19th Amendment, which granted American women the right to vote. Just six months before that, the League of Women Voters was founded with the mission of helping 20 million women carry out their new responsibilities as voters.



But as LWVUS President Chris Carson notes, "Ninety-seven years later . . . ,

we are *still* fighting for equal access at the ballot box—and an alarming trend threatens to roll back what we've achieved across the last century. That's why the work of the League of Women Voters continues, and that's why Americans everywhere must remain vigilant in protecting their role in our democracy."

Carson enumerates recent changes in the Voting Rights Act of 1965 that have made it possible for states to pass more restrictive voting laws. Says Carson, "The 2016 election was the first presidential race in 50 years without the full protection of the Voting Rights Act, and we felt that impact. In Ohio, 400,000 registered voters across the state were purged from the rolls without notice. In Florida, North Carolina and Wisconsin, the period of early voting was cut down to mere days. Across the country, there were more than 800 fewer polling locations to cast a vote in 2016 compared to 2012 and 2014."

Meanwhile, the Trump Administration's unsubstantiated claims that millions of illegal votes were cast in the last election have encouraged millions of Americans to believe that voter fraud is a serious problem.

In fact, says Carson, "The *real* problems with our election system are polling place closures, cuts to early voting, restrictive voter ID laws and the illegal purge of registered voters. . . . The vote of the poorest citizen is equal to the vote of the wealthiest citizen. Voting is the cornerstone of our democracy and should be a moment at which we are all equal."

In San Joaquin County, the League honors that idea by continuing to register voters and helping them make informed decisions at the ballot box.


