THE PRESIDENT'S MESSAGE



Happy Birthday to the League!

On February 14th 2023 the League of Women Voters will be celebrating it's 103rd birthday! Leagues around the country will be marking this event. Many of you know that the league was founded in 1920, six months before the ratification of the 19th amendment which gave women the right to vote.

Carrie Chapman Catt, a Suffragist, is credited with the founding of the League. It's mission was to help the 20 million newly eligible voters, women, learn about voting. However, from the beginning the League believed that education aimed at all of the electorate, not just women, was needed.

Over the decades the League has been involved with many different activities. For instance, did you know that after WWII the League helped to ensure US participation in the United Nations and served as a consultant to the US Delegation? To this day the League still maintains official observer status to the UN. Another interesting tidbit is that in 1976 the League won an Emmy Award for the Presidential Debates which the League sponsored. The League sponsored debates focused on nonpartisan issues

with the goal of informing voters. The League withdrew it's sponsorship of general election debates in 1988 due to increasingly partisan conditions.

The National League has also been involved in campaigning for voter registration reform, redistricting reform, equal access to the ballot and more. Happy Birthday to the US League!



February 14th is also Valentines Day and a good time to show our love and appreciation for our local league, it's leaders and it's members. Our local league was formally recognized in March 1960 after a group of women in Ventura started organizing it in late 1958.

We have many volunteers and board members who are active and deserve recognition. At this time, I would like to formally thank a few of them who often work

behind the scenes. Many thanks to Pat Butler, who not only is our membership director but is also the editor of The Voter. Thanks also to Karen Savitt, our treasurer, Judy Murphy, our secretary, Matty Park who manages our website, Cheryl Collart who is chair of both the Nominating and Budget Committees, and Chelsea Sutula who handles our social media and public relations. There are many others who dedicate a lot of time and effort to our league as well. We thank you all for your



dedication. Happy Valentines Day to all and Happy 103rd Birthday to the League!

Observer Corps Report

Democracy was at work the last week of January. The Ojai Unified School District Board held three special meetings to hear from the public and to

consider options for rectifying the significant financial shortfall facing the Ojai USD. In each session we heard many members of the community who made passionate and informed public comments as well as multiple emailed public comments.

These meetings were the first opportunity for the school board members to hear each other's perspectives and ideas. All of the members had received much input from emails, phone calls, one-on-one discussions with teachers, school staff, and parents, but seemed restricted from discussing issues with their fellow board members. The state Fiscal Crisis and Management Assistance Team presented their review of the Ojai USD that led to a fiscal health risk score of 67.9%. A score of over 40% is high risk. No action was taken but it was acknowledged that the \$2.3 million deficit must be fixed.

The second meeting presented options for reconfiguration or consolidation of schools and answered questions from board members. No action was taken but more information about the effectiveness of the proposed plans was requested.

A huge concern expressed repeatedly by the teachers, staff, and community members was the current superintendent's lack of trustworthiness and transparency. No Board member had addressed this concern at any of the meetings. One parent spoke and presented notification of a petition to recall his elected Board member. A recall election is part of our California democracy, but
