Protecting Our Neighbors: Safeguarding the Rights of Our Entire Community

April 19, 6:30 – 8:30pm Woodside Road United Methodist Church,

Jay Laefer will discuss the latest efforts by the American Civil Liberties Union to defend everyone's rights here in California and across the country. Nationally, the ACLU has opposed the Trump administration's Muslim Ban and sought to protect immigrant communities from federal overreach.

Here in California, the ACLU has launched an effort to reform our bail system so that no one sits in jail simply because they cannot afford to post bail. (AB42 & SB10)

Other legislative priorities: * **SB54:** California Values Act (disentangles state & local law enforcement agencies from immigration enforcement) * **SB31:** California Religious Freedom Act

Jay Laefer has been a volunteer activist with the American Civil Liberties Union since 2002. He has worked on a variety of civil liberties issues ranging from law enforcement accountability to preventing library censorship to criminal justice reform. Currently, he serves on the board of the ACLU–North Peninsula Chapter.

FROM THE BOARD

Current California Legislation

As many of you know, a portion of our dues goes to the California League to maintain a small permanent group of volunteers and employees in Sacramento. They follow California legislation throughout the year, expressing the views of the League to the state legislators and letting us know what bills are in process. To find more information on their work, go to LWVC.org, click on Take Action, then under Legislation click Read More. There is a great deal of information available on pending legislation. The following is a brief precis of some of the current bills on which the League has taken a stand:

Campaign Financing:

AB 1089 (Mullin) Local elective offices; contribution limitations. The League supports this bill. (LETTER.)

AB 1678 (Berman) School districts and community college districts; political activities; dedicated fund. The League is a sponsor of this bill.

Coastal Issues:

SB 44 (Jackson) State lands; coastal hazard and legacy oil and gas well removal and remediation. The League supports this bill.

Housing:

SB 2 (Atkins) Building Homes and Jobs Act. Support. (LETTER.)

SB 3 (Beall) Affordable Housing Bond Act of 2018. Support. (LETTER.)

Immigration:

AB 3 (Bonta) Public defenders; legal counsel; immigration consequences; grants. Support.

SB 6 (Hueso) Immigrants; removal proceedings; legal services. Support.

SB 31 (Lara) California religious freedom act; state agencies; disclosure of religious affiliation information. Support.

SB 54 (De Leon) Law enforcement; sharing data. Repeals provisions requiring that persons arrested for specified controlled substance violations and possibly not US citizens be reported to the appropriate US agency. Support.

Voting Rights:

AB 216 (Gonzalez Fletcher) Vote by mail ballots; identification envelopes; prepaid postage. Support.

Additional information on all of these bills, and others, is available on the LWVC.org site. (Note that the first two have been introduced by our local Assembly members, Kevin Mullin and Mark Berman.) Where I have included "LETTER" the site links to a letter from the League giving our reasons for supporting the bill.

If you are looking for something to do to help our state in this current crisis, you might consider writing to your Assembly representative or to State Senator Jerry Hill about one or more of these bills. (Letters to Senator Hill about the two Housing issues, SBs 2 and 3, might be based on the League letters.) Also, it seems to me that our legislators should be thanked for the good things they do, as well as questioned when they seem remiss.

PS For those of you who are as green as I was (and I am still a delicate shade of pea), AB stands for Assembly Bill and SB is Senate Bill. Happy spring!! Ellen

Timely Topic Conversations Series

Fake News Discussion With David Iverson

Thursday, April 13, 7-9 pm

Did you miss the recent Palo Alto panel "How to Navigate Information in a World of Fake News and Alternative Facts?" Or want to further examine this timely topic in a more conversational setting? Come hear award-winning journalist and independent filmmaker Dave Iverson lead an informal discussion about this important issue.

How does one counter "Fake News" when a friend claims it is the truth? When presenting the facts doesn't appear convincing? Iverson will help us discover how we can act in today's climate where proliferation of fake news is affecting our democratic process.

Iverson's career has spanned broadcast journalism and independent filmmaking. His most recent film is *"Capturing Grace"*, a feature documentary about a group of dancers with Parkinson's disease and their unique collaboration with the worldrenowned Mark Morris Dance Group. The film was broadcast on PBS in 2015 and won numerous awards and was screened to sold out audiences around the country and internationally.

Iverson was also the writer, correspondent and co-producer/director of the 2009 PBS *Frontline* documentary about Parkinson's *"My Father, My Brother and Me"*. He is a National Emmy Award winning documentarian, a special correspondent for the *PBS NewsHour* and a radio host at San Francisco's NPR affiliate KQED.

Iverson now serves as Contributing Editor at the Michael J. Fox Foundation for Parkinson's Research and is a founding member of the foundation's Patient Council.

Ken Broome (May 19, 1925 - March 11, 2017)

Ken and his wife, Heather, were longtime League members. Heather was our VOTER Editor for years until her death in 2008. Ken often attended our events until this past year, sometimes speaking up to suggest specific projects or causes the League could support in transportation and housing. He and Heather were both born in England and immigrated to the U.S. in 1952, with the first two of their eventual six children. As an engineer (MA from St. Johns College, Cambridge) Ken first worked in aerospace in Southern California and Florida. Ken and Heather's third period of residence in California was here in Woodside beginning in 1994.

I have had a number of engineering, infrastructure and public policy conversations with Ken at League meetings and occasionally for a breakfast or lunch to talk about some project. He and I have both done small research projects for the California Energy Commission, his being "micro-hydro" - small scale hydroelectric power - and mine being "bioenergy" from renewable woody wastes. I miss our exchanges and his "can and should be done" challenges in energy, transportation and housing.

Anne DeCarli, who is a resident at Brookdale in Redwood City where Ken lived tells us that Ken was a member of the board of the Residents Council at Brookdale. She adds that members appreciated his learned and thoughtful contributions to discussion, and she mentions that one of his causes there was his urging that they install solar panels on the roof.

Note: A service is planned for 11 am on May 27 at Our Lady of the Wayside chapel in Portola Valley, with a gathering for remembrances afterwards on the grounds.
