Marc Berman was elected to the California Assembly in November 2016 to represent the 24th District. A lawyer by training, he previously served on the Palo Alto City Council and as Development Director at the Silicon Valley Education Foundation. Marc was a leader on the City Council on issues such as financial transparency (providing the public with an easy-to-understand summary of hundreds of pages of budget documents) and infrastructure improvements (committee for Measure B to help fund public safety, street and park improvements). Marc graduated from Georgetown University with a Political Science degree, and from law school at the University of Southern California.

STATE CONVENTION REPORT from Shirley Des Marais

Four members of our League, Tracy Clark, Diana Post, Corrie Potter and I had the good fortune to represent our League at the State League Convention in Sacramento June 2-4. Not only were we able to discuss and vote on State League procedures and positions, we also attended workshops offering information and suggestions to help local Leagues with important issues, which we will be sharing with board members, chairs and committees in the upcoming months.

Delegates adopted the following LWVC Program for 2017-2019:

Retain current positions

Issues for Education and Advocacy:

- Making Democracy Work in California
- Natural Resources, including climate change, water, and land use/CEQA (California Environmental Quality Act)
- Response to changing federal policies and budget actions that have an impact on California in areas such as healthcare, immigration, the environment, and tax reform

These automatically become issues that we can use in our own local program.

We also adopted new State League Bylaws. They have been completely rewritten to remove details, making the Bylaws easier to understand and requiring fewer changes. The thought is that the details of running the League belong in the Board Policy and Procedures, where it is easier to make changes by the Board, and not wait for two years to be changed at Convention. Local Leagues are welcome, but not obligated, to follow the State League model.

Finally, we had the opportunity to attend caucuses. Some were aimed at lobbying attendees to support a local League's motion for adoption at the convention. At others, Leagues shared programs that they've implemented at their local level. The Los Angeles League shared their progress on Community Relationships with the LA Police Department. Their experience could be a great help to us as we begin to consider our own issue of community policing.

Looking ahead to next year, the National League will hold their biannual convention in Chicago, June 28 – July 1, 2018.

Timely Topics Conversation Series: China & the US with Dr. Nicholas Hope— Summary by Linda Liebes

Dr. Hope, aka Nick, Ellen Hope's husband, graciously met with us at Susan and William Grindley's historic home to follow up on his talk to us at our Annual Meeting. He said that when he spoke at our Annual Meeting on May 16 he had just gotten home from China and might be called an expert. This evening, five weeks later, he claimed he was not.

Of course, that is not true. Dr. Hope is truly an expert, not only on China, but on all of Southeast Asia, and more importantly, he thinks outside the box. As one who wants a win-win for every nation, he comes up with solutions such as making the islands near Taiwan international heritage zones, which could defuse dangerous political situations. Such rational thinking, however, is rarely accepted by politicians, and unfortunately, this suggestion was not taken up.

Dr. Hope said that he views the major topics in U.S. relations with China as: 1) trade and investment issues; 2) climate change; 3) nuclear war, especially in regard to North Korea; and 4) the South China Sea. He thinks that the current U.S. administration has yielded leadership to China on items 1 and 2, which is regrettable.

He had high praise for China's development, which, while it has benefited China's wealthy class the most, has also been a tide that has lifted all boats. For example, in 1994 annual GDP was \$600 billion, or \$500 per capita. By 2016, annual GDP had risen to \$11.2 trillion, or \$8,110 per capita.

Kevin Mullin is now in his 3rd term representing the 22nd District in the California State Assembly. As Speaker pro Tem for the 2016-17 legislative session, he presides regularly over Assembly floor sessions, where he makes rulings on parliamentary inquiries and helps ensure bi-partisan cooperation and civility during Assembly floor sessions.

Elections reform and strengthening our democracy is Kevin's top legislative priority. He is also focused on creating economic opportunity for all, transportation infrastructure and congestion relief, affordable housing, maintaining a balanced budget with a rainy-day fund, as well as clean tech and nurturing our innovation economy.

Kevin graduated with a B.A. in Communications from the University of San Francisco, and a Master's degree in Public Administration (M.P.A.) from San Francisco State University.

President's Report

Ellen Hope recapped the highlights of her term including the following:

- The national and state election had many reasons for the league to be involved.
- In the state, we had 17 propositions to consider and our LWVSSMC held more than 20 Pros and Cons discussions in the community.
- Held 4 candidate forums in Menlo Park and East Palo Alto
- Our December meeting featured a discussion of the ongoing housing crisis in our area
- In January, we had an information booth at the Community Action Rally in Redwood City. Our general meeting covered energy choice issues. Also in January, we attended Bay Area League day also focusing on housing crisis issues.
- At County League day in February we heard lively discussion about energizing youth in civics and democracy.
- March meetings focused on Fake News
- In April, we hosted a speaker from the ACLU discussing how to defend ours and our neighbors' rights as citizens.
- This coming summer we anticipate meetings with our local representatives and hearing a discussion led by a Stanford Law Professor on Voting Rights.
- Kathleen Weisenberg and Ellen Kitamura discussed local programs we are involved in: New Voices for Youth and consulting with the Alumni Consulting team from Stanford.

Remarks by President-Elect

Shirley Des Marais thanked the membership for electing her President and for their confidence in her. She made a request for volunteers to help us reach our goals. She especially asked for help with Communities and Law Enforcement, Voter Outreach, Housing and Transportation, and for our Observer Corps.

BOARD NOTES from the June 19th meeting:

- CA League has completely changed all the state bylaws, which are posted on their website. We may adopt their model if we want, but are not obligated to.
- Committee chairs and off board directors approved as written.
- Reaffirmed board policies and procedures; revised June 2017.
 We hope to have a joint meeting on Sea Level Rise with Palo Alto LWV some time this fall.
- County league needs to present to SM Board of Supervisors recommending a citizens group oversight for Safer Bay.
- Ann Draper reported Kathy Tyson of North & Central LWV would like to connect all Bay Area leagues on common topics. Need to have short articles in Bay Area Voter to review the topics. Perhaps need to have elections to have representative to the Bay Area Council.
- Patti Fry discussed National Voter Corps would like to come under the wing of a League. They are presenting July 8 at Rinconada Library in Palo Alto.
- Common Cause wants to build coalitions with other organizations. They are working on protecting our democracy.

- Possible speaker on transportation from Stanford for our Fall Kickoff in September.
- International Rescue committee available to talk about international refugees. Suzanne will follow up.
- Kleman Institute (gender research) Caroline Simard neighbor of Lisa, is willing to talk to us about gender in workplace.
- Important to relate all of our speakers to our LWV positions; perhaps work the connection into our intro of each speaker.
