FALL KICKOFF & SEPTEMBER GENERAL MEETING

We are again grateful to longtime member (and past president) Lida Urbanek for opening up her lovely house and garden to us for our Fall Kickoff, on Saturday morning, **September 23, from 9:30 until noon.** Catch up with other members and meet new friends over refreshments. Our speaker will begin at 10 o'clock, followed by a Q & A session. We will conclude with a League meeting. The address is 75 Tuscaloosa Avenue in Atherton.

The California Voter's Choice Act (SB 450) is the topic of the day, presented by **Jim Irizarry**, our County's Assistant Chief Elections Officer. This election reform bill, signed last September, makes voting easier by expanding early and mail-in voting, increasing drop-off options, and by allowing in-person voting throughout one's county of residence, not only at a specified precinct, nor only on one day.

He will also address our Voter Registration information, its collection and safeguards, and how California is handling the recent request by the Trump Administration's Voter Fraud Commission, for all voter registration information--including partial Social Security numbers, military statuses, political party registrations and felony records.

From the President

Although we've had a busy summer, fall always feels like a new beginning. The official start of the coming League year is our Kickoff, where we will discuss current and upcoming activities and programs. Our speaker, Jim Irizarry from the San Mateo County Elections Office will answer our questions about the Voter Fraud Commission inquiries. He will also explain the state's new Voter's Choice Act and how our county will be implementing it.

The Voter's Choice Act was passed in 2016 to modernize California elections by allowing counties to conduct elections under a new model that provides greater flexibility and convenience for voters. San Mateo County was chosen as one of four in the state to participate in a trial run during the 2018 election. The County will be holding meetings in late September and early October asking for public input on how Voter's Choice should be implemented, such as where Vote Centers and Drop Boxes should be located. They particularly want to hear from language minorities, people with disabilities, and other historically underrepresented communities.

The State League is hoping to prepare the public to participate in the County meetings by educating voters now about Voter's Choice. They are targeting community groups with the hope that they will then educate the members of their various groups.

The North and Central League's September General Meeting will be one of the State League's educational meetings. State will send emails to San Mateo County community groups inviting them to the meeting. Our League has been asked to help staff a phone bank with follow-up calls to encourage each group to attend and answer any questions that they may have. Please consider helping out, September 6, 10 – 4.

The Future of Voting





Starting in 2018, all registered voters in participating counties will receive their ballot in the mail a month before the election. You have **3 choices** for how to vote.

VOTE BY MAIL

You can mail your ballot starting as soon as you receive it.

DROP BOX

You can drop off your ballot at any secure Drop Box starting as soon as you receive it. No postage required at Drop Boxes.

VOTE CENTER

You can go to any Vote Center in your county to vote in person. Vote Centers will be open for up to 11 days in a row. At every Vote Center you can:

- Vote
- Register and vote the same day
- Drop off your ballot
- Vote with an accessible voting machine
- Get help and voting materials in multiple languages

WHY THE CHANGE?

The California Voter's Choice Act became law in 2016 to make voting more convenient and accessible.

- You choose HOW you vote: Whether using the mail, a Drop Box or a Vote Center, you choose the method that works best for you.
- You choose WHEN you vote: Instead of just one day to vote, you can vote in person during an 11-day period—including weekends—ending on Election Day.
- You choose WHERE you vote: You can vote in person at any Vote Center in your county.
- You get the SUPPORT you need: Vote Center staff will be there to help you have a great voting experience, including providing assistance in multiple languages and helping voters with disabilities.

RECAP: Dr. Pamela Karlan's Talk, June 27th General Meeting Voting is a constellation of 3 major concepts: (1) Participation is when we register to vote, cast our ballots, and have them counted. In the 1960s and early 1970s, there was the presumption that any restriction on the right to vote should be subjected to the strictest form of judicial scrutiny, as the right to vote is preservative of all of our other rights. Now the pendulum has swung to the concept of not putting 'undue burden' on voting access, which has had detrimental effects in many states, though not so much here in California. A summary statistic: for each time actual voter fraud is avoided by those burdensome voting restrictions, 7,000 eligible voters are denied their right to participate!

- **(2) Aggregation**, or how we collectively decide on our election rules—which have been questioned ever since implementation in 1842. That is, if you can't change the rules about HOW votes get counted, then you might try to change the rules about WHO gets counted—think gerrymandering!
- **(3) Governance**—how is government policy made? Essentially, election day is the end of campaigning and the beginning of governance. The US is now politically hyperpolarized unlike it has been any time since the 1870s; the ideological overlaps between 'liberal' Republicans and 'conservative' Democrats vanished in 2010, as gauged by the Poole-Rosenthal score.

How did Trump become President? The major political parties are not so distinctly cohesive parties as they were; the spectrum is wider, there are more candidates and a splintered electorate. The rise of social media has made it very easy to access a variety of information (and disinformation!) such that people can choose to hear only their desired messages. These ideological slices can be considered 'narrow-casting', as opposed to the former prevalence of 'broadcast' television.

The electoral college is not going away. The political parties are wedded to it; if some states wanted to change to state-wide or congressional-district-wide electors, disadvantages would accrue to any states not playing by the same rules...

There are something like 80,000 voting precincts in the US, most of them not interconnected. The only advantage of our disorganized voting system is that it is **hard to hack!** Ms. Karlan is far more concerned about the consequences of saboteurs taking down the electricity grid on election day, and by disinformation campaigns, or candidates who can be bought.
