On December 1, 2017, 128 letters were sent to our members (14 to couples) and 53 friends and former members asking for donations to our Education Fund. 48 donations were received, a response of 27%. 31 members contributed a total of \$4,900 and 17 friends contributed a total of \$3,110 for a grand total of \$8,010.

Stuck in traffic one more time? Empty buses passing you? A variety of trains and buses but not enough co-ordination? Would you use them if you could? if you knew their schedules? if there was an easy app? if they took you where you needed to go?

A coalition of regional leaders, transportation experts, employers, nonprofit groups, and others has been brought together to find a solution to San Mateo County's transportation issues. This is called the Stakeholder Advisory Group and uses GUM (Get Us Moving) as a motto. While the League doesn't have a position on any solution, including a possible sales tax measure in 2018, the League is represented on the Stakeholder Advisory Group. Jackie Jacobberger (LWV North & Central SMC) and Barbara Wallis (LWV South SMC) are the League representatives to this group.

You should have received a brochure in the mail with a survey seeking input from all residents on their top priorities for improving transportation in San Mateo County. **Do** fill it out and return it promptly. It is postage paid; no need to look for a stamp.

If you discarded the large card, take the survey online at <u>www.GetUsMovingSMC.com</u>. The deadline is February 28th. The Stakeholders Advisory Group will review the responses and potential project proposals. We want your voice to be heard!

In Memoríam

Adelaide Veronica Iverson

Aug. 17, 1912 — Dec. 20, 2017

Our League lost a long-time member and exceptionally bright and caring human being when Adelaide Iverson passed away at her Menlo Park home on December 20, 2017. She was 105 years old.

Adelaide's life was one of service to family, friends and community. She received a Master's Degree in history from the University of Michigan and began her teaching career in Grosse Point, Michigan. Adelaide was active in the League of Women Voters for many years, serving as president of our local League from 1968-69. Her husband Bill joined the faculty of Stanford University in 1950 and from then on Adelaide became a passionate supporter of all things Stanford, particularly its sport teams. When she was 95, she threw out the first pitch at a Stanford baseball game, and word was she had a pretty good arm.

To honor her remarkable life, the family suggests donating to the League of Women Voters of South San Mateo County Education Fund, PO Box 2244, Menlo Park, CA 94026 or to the Catholic Community at Stanford University, P.O. Box 20301, Stanford, CA 94309.

We also heard from Onnolee Trapp that Marty Tarshes passed away on December 26th at The Sequoias.

From the President

A lot has happened since our last newsletter was published. In December, we met for our Annual Holiday Dinner and Program Planning Meeting, where we agreed to accept the National Board's recommendation to continue their emphasis on **Making Democracy Work**. This includes Voting Rights, Improving Elections, Campaign Finance/Money in Politics and Redistricting. Leagues throughout the country are sending their recommendations, and final National Priorities will be approved by delegates to the National Convention in July.

In January we met to discuss recommendations for our 2018-19 local and county programs. For local, we decided to continue Voter Outreach, and added Housing. They will be brought to the membership for approval at our Annual Meeting in June. We recommended that the County League keep our current emphasis on Housing, Transportation and Climate Change/Sea Level Rise. The North and Central San Mateo County League came to the same decision, so these Issues for Emphasis will be presented for approval at our joint County League Day event on February 24 (see article in this issue for details).

Several new committees have gotten started this month. Our Tech Committee met to begin our discussion on how to update our IT system. Thanks to Juanita Croft who agreed to head up our efforts. We have begun the process of converging our Education Fund with our League fund into one entity and I am grateful that Patti Fry has agreed to steer us through the process.

Thanks also to Lynn Auslander, our new Communications Chair. She met with her committee to discuss ways to get our message out in a timely, coordinated manner. Debby Maio has been busy setting up our new website, which will be online soon. Thank you, Debby!

And finally, a big thank you to Geoff Ryder for agreeing to lead our Voter Outreach efforts. In this election year, I hope you will all consider helping us in our efforts to get all eligible voters registered and informed and ready to vote to help **Make Democracy Work**.

Appointment of 2018 County of San Mateo Charter Review Committee

On January 9, 2018, the San Mateo County Board of Supervisors appointed 17 people to serve on a committee to review the County's charter. Two additional members will be appointed at a later date. One of the committee members was designated by the Board to be filled by a League member. The combined San Mateo County Leagues nominated Ann Draper to serve on the committee and she was appointed. The committee is required to provide the Board with a recommendation by June 30, 2018. Specifically, the committee is requested to review (a) the consolidation of the offices of controller and treasurer-tax collector into a single appointed Director of Finance position, or, in the alternative, whether the separate offices of controller and treasurer-tax collector should be changed from elected offices to appointed offices; (b) technical and administrative clean-up items concerning matters such as the appointment process for the County Manager and the consolidation of the Office of the Assessor-Clerk-Recorder.

Sea Level Rise Vulnerability Assessment

On February 27, 2018 the Board of Supervisors will consider a sea level rise vulnerability assessment for San Mateo County. This assessment has been under development for approximately two years. Both San Mateo Leagues have taken an active role in the review of the assessment. In September 2017, the two Leagues wrote a letter to the County with comments on the draft assessment. The public is welcome to attend this Board of Supervisor's meeting. (9 am until noon, Board Chambers, Hall of Justice, 400 County Center, Redwood City.) The two Leagues will be sending a letter supporting the assessment and encouraging next steps. San Mateo is the most vulnerable county in the State of California to the impacts of sea level rise and one of the most vulnerable in the United States. Therefore, it is important that each city and governmental agency use the information to lower flooding risks and make prudent public investments.

HIGHLIGHTS from the January 11th BOARD Meeting:

Your Board

- Approved the membership recommendations for maintaining our current National Priorities (Voting Rights, Improving Elections, Campaign Finance/Money in Politics and Redistricting).
- Retained Housing and Voter Outreach as our Local Issues for Emphasis.
- Recommended retaining Housing, Transportation, and Climate Change/Sea Level Rise as County Issues—and will confer with North & Central at County League Day.

Discussed

- Potential technological upgrades and issues, under the aegis of Juanita Croft and our newly-formed technology committee.
- The benefits of having a more interactive website for all, and especially for chairs and directors to extract data, read about procedures, and distribute information paperlessly.
- The importance of using all types of social media to reach all of our members; Rita Comes Whitney is our social media guru.
- Whether the Board should theoretically permit Members to attend meetings by phone rather than in person. Determined that this is not something we wish to encourage, but approved the idea of a trial if needed.
- The possibility of a fundraising event at the soft opening of a new hotel in Menlo Park.

Learned

- Legislative interviews are coming up; Shirley is looking for seasoned members interested in participating.
- That if we convert to a single entity, we will have to adopt new bylaws and give notice to members in advance of the Annual Meeting.
