Poll Workers Needed

Did you know?

It takes about 1,000 poll workers to effectively conduct the General Election in Pulaski County. In a recent survey conducted by the <u>Pulaski County Election Commission</u> 403 of our existing poll workers are willing to work the polls this November, but 241 said no, and 70 are on the fence.

The average poll worker in Pulaski County is 73 years old, which is a group very vulnerable to COVID-19. We have more poll workers over the age of 90 than aged 18-25.

We need younger folks to serve as poll workers to keep our older generation healthy, protect our democracy, and ensure a safe and efficient election process this November. Please consider serving yourself, or encouraging those in your circle that are not vulnerable to long term effects from COVID-19 to apply!

LITTLE ROCK CITY HALL NOTES

As this VOTER goes to press, the four positions on Little Rock City Board up for election on November 3 all have candidates. To be voted on in November are the three At Large Board positions and Position 4. At this time Position 4 incumbent Capi Peck and At Large Director Dean Kumpuris do not have opposition. At Large Director Joan Adcock has one opponent. At Large Director Gene Fortson is not running for reelection and three candidates are running to replace him on the Board. The period to file for any of these positions ends August 14.


LITTLE ROCK SCHOOL BOARD ELECTION

On November 3 the Little Rock School Board will hold their first election since the District was taken over by the State more than five years ago. The Board has been reconstituted with nine members, and as of this date, most districts have at least one candidate. Check online with LRSD or Pulaski County Clerk web pages to determine what district you are in, and when thinking about the races on the November 3 ballot remember there are school board candidates as well as national, state, and city races.

BLACK WHITE EQUITY IN LITTLE ROCK

The following information is from the Metro Trends - Demographic Review and Outlook August 2020 publication. Put out by Metroplan, it provides statistics on population change, housing trends, and impact of Covid–19 on Housing. One set of statistics in this issue deals with housing inequity between white and black residents of Little Rock. The white households for these statistics are defined as white/non-Hispanic. That definition is used because the Hispanic population of Little Rock is not considered statistically significant by US Census standards.

In the Little Rock area 65.1 percent of all households own their home. Among black Little Rock households 43.7 percent own their home. Among white households in Little Rock 73.0 percent own their home. Part of this different is due to another statistic – black household income in Little Rock is 59.6 percent of white household income. In another section of the publication dealing with housing costs in Little Rock it was pointed out that income levels in Arkansas and Little Rock is less than in many states, and results in a considerable number of residents paying more than 30% of their monthly income for housing.
