October LWVPC Meeting: Why should we abolish the Electoral College? by Pat Landes

You are invited to the LWVPC regular monthly membership meeting on <u>Monday</u>, <u>October 19</u>, <u>at 6 pm</u> via Zoom meeting platform to hear about abolishing the Electoral College. This meeting is timely since we will be hearing about the Electoral College in the coming months related to the November presidential election.

We are fortunate to have sister League member, Rosemary Heilemann, present to us. She has been in various Leagues for over 40 years and is currently on the LWVIL Electoral College Committee. I saw this presentation recently in a class I was taking and thought it was timely, compelling, and informative of the League's position (listed below).

The League's position on the Electoral College is: The League of Women Voters of the United States believes that the direct-popular-vote method for electing the President and Vice President is essential to representative government. The League of Women Voters believes, therefore, that the Electoral College should be abolished. We support the use of the National Popular Vote Compact as one acceptable way to achieve the goal of the direct popular vote for election of the president until the abolition of the Electoral College is accomplished.

Notice and Cure Lawsuit Ongoing

The complaint against Sec. of State John Thurston and the Pulaski County Board of Election Commissioners was filed. Our request for expedited review was denied by Federal Judge P.K. Holmes III. He stated that the defendants needed time to respond and to propose other solutions. We are asking that voters who make minor errors in their absentee ballots, such as an incorrect date or failure to fill out or sign the form be given a chance to 'cure' the error. Also, if a signature is deemed to not match, the voter will be given the opportunity to show proof of their identity and signature. The cure period is from the time the commissioner reviews the ballot until three days after the election. Currently, voters are allowed to bring in copies of their photo ID if they fail to include this in the ballot envelope, and therefore, this is just another opportunity to fix problems. Arkansas would join Georgia, South Dakota, Virginia, and several other states in allowing voters to take care of minor errors instead of having their vote thrown away.

Observer's Corps

FROM LITTLE ROCK CITY HALL

Much of activity at City Hall the past few weeks dealt with education. Dr. Jay Barth, Little Rock's Chief Education Officer, announced the names of the four LRSD schools who have been designated "community schools" They are: Chicot, Stephens, Washington, and Watson elementary schools. The community school concept is to facilitate connections between students and their families with community services that may benefit the educational experiences of the children. There will be a staff person on site at each school with the responsibility of helping this happen. Besides City of Little Rock, LRSD, PCSSD, CALS, ArKidsRead, UAMS Psychriatric Research Institute are partners in this project.

Later in September Mayor Scott announced the creation of two new education focused groups. The Mayor's Council on Higher Education will develop cross campus linkages and help develop a plan for a college saving account program. Leaders from local institutions of higher learning and other learning institutions plus others including a student will make up this group. The Lifelong Learning Cabinet's creation was also announced. Its membership will be made up of three representatives from the City's Commission on Children, Youth and Families, the Excel by Eight Little Rock Steering Committee, Ford Next Generation Learning Academies Steering Committee and the above cited Mayor's Council on Higher Education. The Cabinet, chaired by Dr. Barth, will meet quarterly to share information and work together to benefit education in Little Rock from pre-school through college. Dr. Barth plans to set up the Council in October and November and begin their quarterly meetings in 2021.

Will There Be Disturbances at the Polling Places?

The race for US House of Representatives in the 2nd District between French Hill and Joyce Elliott is going to be close. There will be challenges to just about every possible thing when counting starts. With the number of absentee ballots to count, don't expect to see results immediately. The primary runoff between Joy Springer and Ryan Davis was decided by one vote, an overseas ballot that arrived after the election day. In this close election, every vote will count. If anyone hears of any threats or instances of intimidation at polling places, such as people openly carrying guns and signs to scare people away, please contact the County Board of Election Commissioners at (501) 340-8383. Or, call or text 1-866-OUR-VOTE – that's 1-866-687-8683. Trained election protection volunteers are standing by to help you navigate any voting problems.

League leaders are expected to be nonpartisan, however, individual League members are not required to maintain nonpartisanship. You are free to express your opinions and thoughts. Just be sure you say this is your opinion and not that of the League. For some races, you can send the person to the recorded forums on YouTube or Facebook. But, everyone, please vote NO on Issue 3, the legislature's effort to silence citizen-initiated ballot issues. The requirements would make it very expensive and extremely difficult to get enough signatures by the earlier required day of submission. Plus there would be no cure period to get the last few signatures if you fell short. And, instead of 15 counties, signatures must be collected in 45 of our 75 counties.

Issues That Matter

Issues That Matter: On the Ballot and in the Voting Booth occurred virtually on September 17, 2020. There were 122 total virtual attendees. Six panelists: Jay Barth (Poli Sci Prof. Emeritus), Kristin Higgins (UA Extension Services), Preston Eldgridge (Attorney), Kenny Hall (AR Chamber of Commerce), Melissa Fults (Marijuana Ballot Initiative Driver), and Joshua Price (Pulaski Co. Election Commission).

The panel began with Price discussing the complexities of voting during the COVID-19 pandemic, and the steps the Commission and the Clerk's office are taking to ensure that poll workers and voters remain safe. Many viewers posed questions to Price to help clarify any questions about the validity and security of mail in voting, expanded early voting locations, and what election day will look like.

The next section of the forum centered on how voters can get issues on the ballot and what ballot issues will be there in November. Kristin Higgins gave a very thorough overview of the issues remaining on the ballot, more information can be found in the <u>Voter Guide</u> that the extension office releases every election. Many thanks to Kristin for her hard work on that. There was also a short overview of how issues 4-6 were removed from the ballot due after court battles.

Issue 3 was then discussed pretty heavily. First, Jay Barth gave a pretty thorough overview of the citizen ballot initiative process as it currently stands. A good summary of that is available in his Encyclopedia of Arkansas article: "Initiatives and Referenda," and how Issue 3 would alter this process. After Barth gave general context, Kenny Hall spoke on why the legislature wanted this measure on the ballot. After he gave that justification, Preston Eldridge and Melissa Faults discussed their own experiences both attempting a ballot initiative by petition, and defending the process in the court room.

Overall, the discussion was very lively and informative. Thank you again to KUAR and CALS for partnering with the League to make this happen. So far, the YouTube video has over 50 additional views.

North Little Rock Mayoral Forum Success

IMPORTANT PULASKI COUNTY ELECTIONS INFORMATION 1 NEW EARLY VOTING TIMES, NEW LOCATIONS AND VOTE CENTERS

by Debrah Mitchell, Assistant Chief Deputy, Office of Pulaski County Circuit and County Clerk As the November 3, 2020 general election quickly approaches, Pulaski County Circuit and County Clerk Terri Hollingsworth shared new important information for registered voters with community, educational, civic organizations, and the media.

EARLY VOTING

- Sites: Pulaski County voters have three new early voting sites bringing the total to 12 sites.
- Dates: Early voting will begin on Monday, October 19 and will run through Monday, November 2, 2020. There will be two Saturdays to early vote October 24, 2020 and October 31, 2020. No early voting is available on Sundays.
- Times: Now all early voting sites will have the same hours 8:00 a.m. until 6:00 p.m. Monday through Friday and 10:00 a.m. until 4:00 p.m. on Saturdays. On Monday, November 2, 2020, early voting will be 8:00 a.m. until 5:00 p.m.

ELECTION DAY

- Sites: Pulaski County voters have the option to vote at their assigned polling location *or* one of the 12 early voting sites which become "vote centers" on Election Day.
- Dates: Election Day will be Tuesday, November 3, 2020.
- Times: All 105 polling locations including the 12 vote centers will be open from 7:30 a.m. until 7:30 p.m. Pulaski County now has a total of 117 polling locations.

ELECTION DAY POLLING LOCATION CHANGES

There are several precincts changes for this election. Seven have permanently changed to new locations and nine are temporarily changed for this election. The names have changed at four precinct polling locations.
