# **Need for Notice and Cure for Errors on Absentee Ballots** by Nell Matthews

Even though the polls were not crowded, I don't regret voting absentee this year. I was one of the ones who encouraged all my friends and family to request an absentee ballot. However, hearing that some 4000 ballots in Pulaski County were uncounted because of failure to properly fill out the voter statement leaves me conflicted. As a member of the LWV Arkansas leadership team, I was a party to litigation to require notice and cure of missing information on absentee ballots. However, Federal District Judge P. K. Holmes ruled that no actual disenfranchisement had occurred before the election and thus, he would not issue a preliminary injunction to require a chance for voters to fix or 'cure' their errors. Well, there are 4000 reasons now. ## Absentee Ballots Pending in Pulaski County

25K absentee ballots were received. 20.5K were counted on election night and included in the totals. 4.5K are currently being reviewed by the commission with time given to absentee voters who didn't provide IDs to show them so their ballot can be counted.

By law we give provisional ballots until Nov 9 to provide missing information. Then we approve the provisional and absentee provisional ballots that night. Then we wait until Nov. 13 for overseas and military ballots to come in. Then we certify the final results of the election on Nov 13 -- 10 days after the election.

4,500 total absentee ballots were initially not counted on Election Day due to various issues like missing/incomplete red Voter Statement, etc.

- About 1,200 remakes of damaged ballots that cannot be read by the machine will be counted
- About 2,000 provisional absentee ballots that are signed and will be counted
- 230 absentee ballots redeemed from rejection pile by commissioners personally will be counted

About 1,070 absentee ballots still needing to be sorted and reviewed. This includes provisional absentee ballots with no ID and that were unsigned that can be cured by the voter by Monday 11/9 and the "misfit" irregular ballots. Please note that these are rough numbers. We will have final hard totals on all absentee provisional and early voting and election day provisional ballots by Monday 11/9.
