LWV Program Planning Meeting

"<u>Program Planning</u>" in League-lingo means choosing which issues to work on for the coming year or two. At program planning meetings we decide which of our many positions we want to have as our focus and/or which new issues we want to study.

This year Program Planning will be unique because we are being asked by other Local Leagues to recommend specific positions that those Leagues have already studied and adopted. This agreement is called "concurrence." Those positions are: Criminal Justice, Civil Discourse and we may be asked to support a Voting Systems position. Most importantly, our own League will be seeking concurrence on our own position on Homelessness which we adopted last year. This many Local Leagues seeking concurrence on different positions has never happened before and it is a remarkable tribute to the variety, passion and depth of concern of many Local Leagues in California.

LWVNCSD does program planning every year and all Leagues in California give input to LWV of California in odd numbered years. (All League members in the United States give input to the LWV of the United States in even numbered years.) Then at LWVC and LWVUS conventions the delegates make the final decision for future League action or advocacy. This is how League's grassroots work.

Please mark you calendars and plan to attend this meeting. Your thoughtful ideas and convictions are an important part of the process. We will have a lively discussion and you will leave with a keen appreciation of other members of our League.

Board Report for January 11, 2019

The Board:

- Adopted Guidelines for Evaluating Requests for Endorsements or Opposition of Local Ballot Measures.
- Visting MTA (LWVC volunteer who helps local Leagues coordinate with state League and provides training) Caroline de Llama explained how the State Board chooses legislation to support or oppose in Sacramento.
- Voted to send to the Membership at the 2/23/19 Program Planning Meeting a request from the San Luis Obispo LWV to request at Convention that their position on Civil Discourse be advanced to all local Leagues for Concurrence.
- Began planning our own local League's participation in the state Convention 5/30 to 6/2/19 in Pasadena. We hope to take more than the 6 delegates we are allotted to this Convention to work on getting our own request for Concurrence advanced.
- Learned that LWVC gave permission for local Leagues to march under the LWV name at Women's Marches all over the state. Members will be invited to join us in San Diego.

- Received an update from Social Policy Director Bill Loftus on the extraordinary effort that is being made by the original Homelessness Study Committee to qualify our adopted Homelessness position for presentation at the State Convention in Pasadena 5/30 to 6/2/19.
- Learned that the Margie Monroy Memorial Fund collected \$6,975.00 its first year and that this money was sent to *Universidad Popular* at the request of Margie and her family.
- Learned that Helen Hutchison, LWVC President, has asked our League, along with the San Diego League, to host a workshop on Local Advocacy. We agreed to do so.

In 2019, the Women's Issues Group will focus on voters' education and passage of the Equal Rights Amendment.

We plan to discuss what action we can take to make our members and the public more aware of the necessity to pass the Equal Rights Amendment. Virginia almost became the 38th state this January to ratify the ERA. It passed their Senate but failed to get a majority vote in their House subcommittee. Opponents say that the ERA would strip abortion laws because any government policy that restricts access to abortion would be deemed discriminatory on the basis of sex. We need to counter this argument with reasons why women and men both need equality under the law. Did you know that in 1972 there were only 15 women serving in Congress? In 2019, there are a record-breaking 127 women who hold seats in Congress! The chances of passing a resolution to remove the deadline to pass the ERA has just increased.

Trish Halsey-Monroe, Chair of the voter education subcommittee and an attorney, has in the past assisted ACLU in conducting a onehour, free courses in high schools and elementary schools regarding the US Constitution. Because Constitution Day is September 17th, she is suggesting that our League prepare a similar course or volunteer to teach the course with ACLU. The presentations would be non-partisan, interactive, historical and contemporary. We could also provide voter registration assistance to senior high school students. possibilities are endless, AND if you are interested, please come to the next WIG meeting on Monday, February 25.

Homelessness Count A Personal Encounter

While my primary interest these past two years with the LWV has been with Policy Development for Homelessness, I have found it to be grounding to participate in the annual Point-in-Time-Count (We All Count) census of homeless citizens in my city of Oceanside. Last year I volunteered to join County and City staff at 4:00 am to count homeless individuals We drove around our assigned in our city. census track and simply marked locations and numbers of homeless. This year San Diego County was asked by the US Department of Housing and Urban Development to actually interview homeless individuals. For me and others this put a very different face on the census-taking process because we were being asked to wake up sleeping homeless folks and ask their cooperation in responding to 30 prepared questions about their name, length of time being homeless, their physical and mental health, etc.

I - and others - found this to be a very different experience due the personal interactions I had with individuals I found under bushes, in tents along trails and sleeping in their cars in WalMart parking lots. My individual experience included awakening and interviewing a cooperative 50-year-old white guy who was sleeping on a sheet of cardboard under a bush wearing shorts and a T-shirt. While this wasn't Chicago, I must say that I was bundled up for the 47-degree temp in Oceanside. He understood my interest and answered all the questions on the survey. He became homeless 15 years ago here in San Diego. He wasn't - as some believe - given a one-way ticket from NYC.

While I did interview others between 4:00 am and 8:00 am there was one other family of six living in their car who caught my attention.

The 17-year-old white daughter was walking the family puppy while her parents and siblings slept in the mini-van with all of their belongings. She, too, was willing to respond to my survey at 4:45am. The family lived in the Inland Empire (Riverside?) prior to her dad getting injured and partially disabled at work. While they now live off of his monthly disability check she explained that like many working poor, they had enough for food and shelter but there was no way they could afford a \$2,000 per month apartment in North San Diego County: so the vehicle was their shelter. Her younger brother has cerebral palsy and they continue to have health insurance through her dad's employment. I didn't ask about the children's' schooling because it wasn't one of the survey questions. (23,000 public school students in San Diego County are homeless)

Perhaps I was just lucky but no one on my team encountered psychotic, drug-addicted alcoholics - the common perceived face of homelessness in Oceanside. No one reacted badly to me knocking on their car window or my invitation to respond to a survey from within their camping tent.

I would suggest this was a very emotional experience more than an important clerical task of tallying homeless citizens in order to get funding that would translate into services for this ever-increasing population in our country.

We had a speaker earlier this week at our Oceanside League of Women Voters meeting who told us her work as a non-profit CEO had previously been all about poverty. However, she told us that after the Great Recession of 2008, many poor families lost their homes, had their credit scores dinged, and could not buy property if they wanted to-with many forced into rental markets overheated by investors. Unemployment, she said, is at record lows and yet people with jobs are facing the loss of those rental units because of unforeseen circumstances such as family emergencies and rental rates exceeding working families ability to pay. Something for all of us to think about.

Guns in Our Community Forum on January 22, 2019

Close to a hundred participants came to the community discussion moderated by LWV President Anne Omsted on "Guns in our Community." The tone and manner of discourse were set immediately and the audience was polite and attentive, with one exception.

San Diego District Attorney Summer Stephan and her colleague Fiona Dunleavy prosecuted Kelly Elementary (Carlsbad) shooting and learned from it that there are many facets to the gun issue and "guns are part of that concern." Stephan and colleague Fiona Dunleavy shared that what has emerged from the data is the clear relationship between school shooters and stalking/domestic violence. 44% of domestic violence reports involve guns. The San Diego County DA's Office has started a program called Threat Assessment Protocol Systems (TAPS) to counteract these threats, with San Diego City Attorney Mara Elliott's office spearheading the civil aspect. Family members can have guns removed from a family member by filing a Gun Violence Restraining Order (GVRO), which is issued immediately, lasts for three weeks, and can be renewed if needed. Proposed AB61 allows school and company officers to apply for a restraining order if they feel a member shows signs of mental illness.

Representing Palomar Hospital Trauma Care Director Melinda Case detailed the preventive programs Palomar hospital runs on the safe storage and use of guns, as well as their training on how to stop bleeding and pack wounds. She stated that the majority of the gun wounds Palomar treats are from suicides and that having access to mental health professionals facilitates action to prevent them.

San Diego County Office of Education Assistant Superintendent Dr. Rebecca Mendiola stated gun violence is a systems issue in schools and the community; schools must not only be prepared, they must put the preparation into action, which University of San Diego

was the problem at Parkland. "Parkland school had good systems in place but didn't use them."

Finally, gun store owner Greg Gunther of Gunther Guns in Carlsbad said that the 2nd Amendment protects the rights guaranteed by the First Amendment, and expounded that we need guns not to protect ourselves from each other but from our government, citing Nazi Germany, Communist Russia and other authoritarian societies where the population was in thrall to an armed government. He said that for 90 years we had virtually no school shootings, until suddenly in the 1990's we saw a rise in school shootings--at the time when young people began to be prescribed antidepressants and other mood and behaviorchanging drugs. This causes depression and homicides, especially SSRI drugs. According to Gunther, guns in our society are a symptom, not a cause.

As you can see, provocative and interesting views as well as data were put forth, with questions for the participants requesting them to elaborate on their information.

This was a successful beginning to our threepart series. Member Jennifer Lonbom spearheads the Gun Violence group which put on the discussion held Tuesday evening at the Schulman Auditorium of Dove Library.
