Boerne Independent School District: Board of Trustees

The Boerne ISD Board of Trustees consists of seven members elected by eligible voters to serve a three-year term. Each trustee is elected for a specific numbered place for the term, but does not represent a specific geographical area. The elected trustee represents the entire school district. Elections are held annually on the May uniform election date. Boerne ISD includes portions of Kendall, Bexar, and Comal counties.

Duties: adopt goals and priorities and monitor success; adopt policies and review for effectiveness; hire and evaluate the superintendent; adopt a budget and set a tax rate; and communicate with the community.

2. What is the most pressing issue facing the Boerne ISD School Board and what do you hope/plan to do about it?

3. What are the citizens who live in the school district telling you about school problems?

While there was no blueprint on how to handle a global pandemic, a lack of resources forced the quality of stress level to increase. As parents, we felt the added level of stress to compensate and make up for our students' academic touchpoints. The definition of an essential worker became quickly learned. Teachers are essential. Unfortunately, our students received a minimal level of education.

1. What experience and knowledge qualifies you to serve as a trustee on the school board for Boerne ISD?

Jessica Davila-Burnett: I am a dedicated BISD parent volunteer. My commitment includes: Co-Chair of the Food Allergies committee - Student Health Advisory Council, CHS Choir Booster Club president, VRES PTO, FORES room parent volunteer, and Boerne Education Foundation board member. In 2011, I championed a Texas Public Schools' records bill' to safeguard children with food allergies with Rep. Todd Hunter. My strengths are identifying problems and creating solutions. Using my skill set as a communications and public affairs professional and my master's degree in Organizational Leadership, I will provide transparent communications and work to improve BISD's relationships external partners. **Kate Harrison:** I am a mother of three teenage boys in our district and an Emergency Medicine physician. I worked to design a charter school after college and since 2004 have been teaching graduate medical education. I work daily with a multidisciplinary team to analyze and solve complex problems in the emergency department. Before I make any suggestion I carefully listen, observe and examine the problem at hand – I believe these are translatable skills to the BISD School Board. My knowledge as a physician will bring depth of understanding to our board during the rest of the pandemic.

2. What is the most pressing issue facing the Boerne ISD School Board and what do you hope/plan to do about it?

Jessica Davila-Burnett: We need to reopen our next school year safely and get our students back on campus. Also, strengthening our external partnerships would help to position our fast-growing District favorably with issues around development, mobility, zoning, and infrastructure improvements. Most of all, we need to solidify and communicate a master plan to our community. Everyone single resident within BISD deserves to know everything that is happening in our schools and campuses. I'm a parent first, and I know this firsthand. I am ready to make this happen sooner than later. **Kate Harrison:** Student population growth and recovery from COVID are the issues most pressing to our Board at this time. We expect to nearly double in size over the next 10 years – planning for and meeting this need will take flexibility, careful analysis and excellent planning. We will need excellent fiscal stewardship and communication as we ask our community for bond approval. COVID has impacted student achievement and we'll need to increase individualized learning strategies, re-open the schools to parent and community involvement and enhance our summer school offerings to close the achievement gap.

3. What are the citizens who live in the school district telling you about school problems?

Jessica Davila-Burnett: Residents are asking for more transparent communication. Anything from how to manage our fast-growth district to how we will maintain our talented teachers. Our residents want to know what is happening in the district. I am a professional communicator and have been working in the communications field for almost two decades. I am a crisis communicator and work in public relations, public affairs, and governmental affairs. I am a transparent communicator. Also, most residents want a conservative voice in decision-making and a fiscally conservative approach to managing taxpayer dollars, I bring conservative values to my candidacy. **Kate Harrison:** Most of our citizens are really happy with BISD. After all, we've recently won multiple awards including Best Small District thanks to the great work of our current teachers, staff, administrators, superintendent and board. I hear concerns about the variety of academic choices in high school and continued support for increased counseling and teacher support at all grade levels. Communication and in-school activities have been a challenge during the pandemic, but families tell me they are grateful for BISD schools being open and the extraordinary efforts of the district to stay ahead of the challenges of this year.
