# Fear of Gun Violence in the Community: Daily Impacts and Long Term Effects

The League of Women Voters North County San Diego (LWVNCSD) is sponsoring a four person panel discussion about "Fear of Gun Violence in the Community: Daily Impacts and Long Term Effects." Focusing on factual information about how guns and the fear of gun violence is affecting our community, the goal is to educate our audience about the realities of everyday life in this part of our lives.

District Attorney Summer Stephan will lead off by talking about what laws are in play, what new laws are being proposed, and the daily effect that illegal use has upon our community.

A local school district administrator will tell us about how schools are impacted by the fear of gun violence, emotionally, fiscally and how much time must be allocated to deal with it.

A third speaker will discuss how a law-abiding gun owner who respects the history of guns is affected by the misuse of guns by the few.

A fourth speaker from Palomar Hospital will discuss the impact ofgun misuse on individuals from the perspective of public health.

Then we will ask the audience to make suggestions about what we can do as a community to deal with the wide influence of the fear of gun violence.

We hope you will attend this discussion meeting and share your ideas for dealing with this important issue in our community.

# **Exploring Uncharted Voter Service Territory**

In an offline Mid-Term GOTV effort targeting English and Spanish speaking Millennial parents, the Strategic Communications Committee created flyers to test using messaging specific to that group focused on promoting the Voter's Edge tool.

Olga Gonzalez was instrumental in translating the flyers into Spanish and handing them out at Pros/Cons events for the Latinx community. The flyers were well received and a good support to our Voter Education in these communities.

Arleen von Schlieder focused on the parents of young children by distributing the English flyers at pre-schools mostly in the San Dieguito area including the Bethlehem Lutheran Church Preschool and Day Care, the United Methodist Church Preschool, Encinitas Country Day School as well as the Encinitas Boys' and Girls' Club. Heather Callaghan lent a hand by distributing the Spanish version to the Head Start schools.

Norelynn Pion-Goureau handed out flyers to churches, organizations and libraries in the Carlsbad and Oceanside area.

The team also looked at online channels that show promise in engaging voters. Suzanne Carneiro focused on *Nextdoor* and found it an excellent tool demonstrating great response and far-reaching capabilities. In addition to online reach, another benefit of using this online tool is its ability to foster offline connection and engagement.

After the Mid-Term elections, the Committee met to discuss the GOTV specific messaging to a target audience for what worked well, what were some of the barriers of entry into these communities, and what opportunities exist for planning into 2020.

One of our members, Liz Kruidnier, our local mental health advocate, spoke about several aspects of need in the mental health community. With the information

she presented, the committee decided to initiate a research project concerning housing assistance and availability for behavioral health patients when they have been released from the emergency room or the hospital and back into society but are still in need of help and monitoring.

#### **Oceanside Unit Meetings**

Please mark your calendars for January 22 and February 26 for our monthly meetings at the Buena Vista Audubon Center, 2202 S. Coast Hwy, Oceanside, CA.

For January I have been approached by Teresa Leader-Anderson of the City of Oceanside to share information with our Unit on "Pure Water Oceanside". The project will purify recycled water to create a new, local source of high-quality drinking water that is clean, safe, drought-proof and environmentally sound. The program will produce enough water to provide more than 25% of the city's water supply.

In keeping with our search for ACTIONS our Unit can take to support the new Position on Homelessness adopted last June I am inviting a representative from Dreams For Change to share their mission in serving homeless families living out of the vehicles. Their mission: To respond to the needs of San Diegans by creating innovative and cost-effective programs to empower and stabilize the lives of underserved families and individuals.

In the Spring of 2010 Dreams for Change launched its first initiative, the Safe Parking Program. Two years after the inauguration of the <u>Safe Parking Program</u>, Dreams for Change launched its second initiative, <u>Eat Better Today (EBT)</u> that took the form of the FRESH mobile food truck. In addition to cash, Dreams for Change arranged for the food truck to accept EBT (Food Stamp) cards as payment for hot low-cost nutritious meals. In 2014, EBT expanded further and added the <u>Senior Connections Program</u>, which provides healthy discounted food, support services and activities for seniors in collaboration with Interfaith Community Services.

#### **Homeless Point in Time Count**

The Point-in-Time (PIT) count is a count of sheltered and unsheltered homeless persons on a single night in January. HUD requires that regions conduct an annual count of homeless persons who are sheltered in emergency shelter, transitional housing, and Safe Havens on a single night.

The count will provide better and more detailed data that will be used in the creation of a regional plan, in combination with better data from our new HMIS system.
