Spokane League members will offer voter registration and more information about League activities at the Greater Spokane Valley Rental Assistance event on **Friday, May 14, 2021, noon - 7:00 pm**, at Opportunity Presbyterian Church, 202 North Pine Street. The League table will be set outside the church's entry.

The Spokane Valley Community Advocates, directed by League member Sherri Gangitano, is sponsoring the event, designed to help renters during this difficult time. Inside the church, SNAP staff and community volunteers will assist tenants in applying for SNAP's ERA rental assistance program. There will also be bilingual table volunteers for both Russian and Spanish. The event will assist tenants who live east of Spokane city limits, north to Colbert/Mead and south to Valleyford.

Volunteers are needed for the SVCA portion of this event. (The League table is already covered.) Most positions will require being able to stand for long periods. Some positions require being computer savvy. Volunteers should bring a laptop or iPad with charging cord, and have Adobe Reader available. Shifts are 11:00 am - 4:00 pm and 3:30- 7:30 pm. Volunteers will need to bring their own drinks and masks. ACOVID safety guidelines will be strictly enforced during this event.

Legislative Session Update

It has been amazing legislative session, which finished on April 25. The Washington legislators' goals were to address the economic recovery for Washingtonians most impacted by the pandemic; address criminal justice; and strive toward diversity, equity and inclusion. With an improved revenue forecast and an influx of funds from the federal government, the legislators have accomplished a lot to address the needs of Washingtonians.

Significant bills were passed in the areas of voting rights, climate change, housing, social equity, healthcare, environment, and criminal justice, including:

- HB 1054 prohibits police from using chokeholds, neck restraint, no-knock warrants and allows limited use of military equipment
- HB 1310 requires police to use de-escalation before use of force
- HB 1091 provides clean fuel standards to reduce carbon emissions
- HB 5141 the HEAL act reduces environmental and health disparities and improves health of all Washingtonians by following recommendations of the Environmental Justice task force
- HB 1078 restores voting rights to people upon exit from prison
- SB 5038 bans open carry weapons at public demonstrations and the state capitol
- SB 5160 –addresses landlord-renter relations and provides counsel for evictions due to nonpayment during and after a public health emergency
- SB 1277 requires a document recording fee to create revenue for eviction prevention housing stability services and just cause eviction
- HB 1236 gives renters stability
- SB 5096 helps to fix Washington's regressive tax system by providing a capital gains tax that will fund the Fair Start child care program.

- HB 1297 the Working Families tax credit provides a boost to working families, and extends eligibility to include undocumented workers.
- HB 1342 eliminates school lunch copays for all students who qualify for reduced-price lunches.
