Tips on contacting elected officials

- Most effective way to reach your elected official is in person – visit their office or attend a coffee hour.
- Phone calls or personal emails are also effective.
- State your name and the reason for contact.
- Use your own words. Do not use attack words.
- Refer to a legislative bill by its number if known.

VOTING BASICS

TO VOTE IN MICHIGAN, YOU MUST BE

- U.S. citizen, at least 18 years old on Election Day
- Resident of Michigan and your city for 30 days
- Not currently serving a sentence in jail or prison
- Registered to vote

YOU CAN REGISTER

- At any time up to 8 p.m. on Election Day (as soon as possible for more choices)
- At your city clerk's office. If less than 2 weeks before the election, you **must** register in person
- At any Michigan Secretary of State Office
- Online at www.michigan.gov/vote
- By mail – download an application at www.michigan.gov/vote

IF YOU MOVE

- *Within the city:* Notify the City Clerk
- *To a different city:* Re-register there

ABSENTEE BALLOTS

An absentee ballot may be requested for any reason by 5 pm the Friday before election day. Obtain the form from your local clerk's office in person, by mail, or by downloading from www.michigan.gov/vote

After you vote the absentee ballot, sign the envelope. **Be sure your ballot is received in the City Clerk's office by 8 p.m. on Election Day.**
