Keeping on top of things at our Capitol can be challenging for volunteer organizations. Fortunately, the Iowa League of Women Voters has enlisted the Advocacy Cooperative.



Founded in 2003, owners and partners Amy Campbell and Craig Patterson chose to maintain a smaller, more focused client base and emphasize service, custom game plans, individual attention, and results. They promise strong Capitol Hill lobbying combined with coordinated advocacy campaigns.

Craig has thirteen years of experience including five years in Washington working with Congressman Jim Nussle, then as a lobbyist on the Federal level. Amy has spent more than twenty years in public policy and political processes, including three years as a political campaign consultant. Consultant Tori Squires has more than twenty-five years of experience in grant writing, community development,

public policy, and advocacy for non-profit. She works with the Bill Tracker during session.

Advocacy Cooperative's other clients include AARP Iowa, Iowa Behavior Health Associates, Iowa Developmental Disabilities Council, and the Iowa Library Association, among many others.

The group's services include *Lobbying *Legislative monitoring and reporting *Legislative analysis and tracking *Bill and amendment drafting *Custom online bill data bases *Administrative rules review *Public policy consultation *Grassroots network development *Advocacy training and campaigns *PAC organization and administration *Strategic planning, and more. They work with the LWVIA's published State Public Policy Priorities.

During Session, Advocacy Cooperative issues a weekly Legislative update email. At the end of the Legislative session in May, they conduct an update for us, reporting on what has happened on the issues LWV advocates.

A MESSAGE FROM PRESIDENT HAGEDORN

Be the Bridge that Spans Across the Troubled Waters

For this letter to the members of the LWV-ASC, I ask that we take a realistic look outward at the current state of our country as well as a look inward through our collective conscience. We are living in troubled times, experiencing division and polarization of a proportion that has not been seen in this country since the Civil War. We MUST do better. A functional society must acknowledge



individual differences and rights to opinions while also excluding hate, discrimination or hurt for reasons of race, gender, sexual orientation or political views. And the LWV must take it one step further in acting upon the obliteration of hate.

Let us not forget that the LWV was founded as a "mighty political experiment" to annihilate discrimination of women. As a social science researcher, I know that experiments are designed to support or negate one or more hypotheses. In this case, the hypotheses were:

- Women are capable of comprehending political issues and can cast a well-informed vote;
- Women are capable of playing large roles in public affairs; and can be trusted to make serious and important decisions;
- Women are capable and should hold public office.

The evidence shows that we have confirmed these hypotheses. And now I cast a new hypothesis for testing:

 The members of the League of Women Voters of Ames and Story County can serve as a bridge over the current troubled waters within our community. We can confront, inform, and act against the epidemic of hatred.

To do this, I offer a framework from the <u>Southern Poverty Law Center</u> entitled *Ten Ways to Fight Hate* (https://www.splcenter.org/sites/default/files/ten_ways_to_fight_hate_2017.pdf). The ten ways encourage us to stand-up, join-up, speak-up and teach others.

- 1. Act
- 2. Join Forces
- 3. Support the Victims
- 4. Speak Up
- 5. Educate Yourself

- 6. Create an Alternative
- 7. Pressure Leaders
- 8. Stay Engaged
- 9. Teach Acceptance
- 10. Dig Deeper

And this is exactly what we, the LWV-ASC intend to do.



NEW HOPE FOR THE ERA

In January the U.S. House and Senate introduced legislation to remove the time limit on the Equal Rights Amendment and finally include it in our Constitution. Last year Virginia ratified the ERA bringing the total state count to the required 38. Now it's time for the legislature to pass it and finally include women in the Constitution. Contact your representatives now and urge them to support legislation to remove the ERA's ratification deadline.

MAKING DEMOCRACY WORK AWARD

In honor of its 90th anniversary, The LWV-ASC established the Making Democracy Work Award in 2017. Recently a special committee reviewed the requirements and issued a revised announcement and application form. With this award, the League honors outstanding efforts of individuals and organizations who have inspired others by:

- *Envisioning ways to improve their community

Members of the League who are currently serving on the Board may not be nominated.


The League announces the honorees at its Annual Meeting.
