Individual calls will begin in January, as the list is due by January 31. Membership was suggested as a holiday present. She moved on to the TRY brochure. She asked for volunteers to update the brochure, and then Linda Woytowich will get it published. Randy Lewis volunteered to visit the Auditor to get the updates. Eileen Perfrement, Dorothy Oetter, and Karen Rice will visit the six high schools in Mason County to distribute the brochures while speaking to Civics classes

Steve Duenkel on December 7, 2023. Mark Tuson also added to the questions. They asked 4 questions and summarized his reponses in a hand out. They also added questions for a follow up meeting with him. One of the main concerns was rejected ballots based on signatures. They are using a new machine Tritek that does initial signature verification. The machine identified many ballots that required manual signature verification and/or curing by trained staff. Mr. Duenkel hopes to have more trained election workers in the future. He was also concerned about the vulnerabilities in the voter registration system, deceased and those who have moved out of the precinct. Some Coroners automatically report deceased to the Auditor, but not when the death is in another county. There was also concern among the League members about the unhoused and students studying away from home. There was discussion on inviting him to a general meeting.
