The League is encouraging members to pay dues by January 31, 2025, to be able to include them under the current dues system. The dues received after January 31 will need to be handled under the new system the National League has adopted. National will provide a template for membership we can insert in the local League bylaws.

**Advocacy** Amy reported the Legislative Newsletter email is sent Sundays. She encouraged taking action on Sunday on legislation supported by the WA Lobby Team, and you must sign up for the Newsletter if you are a new member. Chris mentioned that links to get information on Representational Voting are available.

**Programs** The February meeting will be on Housing Justice. Guests will be Julianne Gale from Mason County Climate Justice and Cedar Stewards, students from Cedar High School. This issue is pertinent to the ongoing County Comprehensive Plan Update. Peggy encouraged members to take the housing survey the Cedar Stewards are conducting on line.

**Climate Change Committee** Lynda reported the major activity is participating in the monthly County Comprehensive Plan, usually on the 3<sup>rd</sup> Monday, 6 pm. It was great to see the Cedar Stewards participating every month. The draft plan is due June 30, 2025. Lynda also reported some bills that are coming before the Legislature this session: SWAK and WRAP on recycling. WRAP has been modified from last year's bill.

**Program: Better Representation through Multi-Member Districts** with speakers Chris Mason from Mason County League, Kit Muehlman of Bellingham/Whatcom County League, and Kirsten Rooks of King County League. Kirsten reviewed various election methods, and Kit and Kirsten explained how Multi-Member Districts relate to Proportional Representation. House Bill 1448 is under consideration this session.
