EXECUTIVE AND COMMITTEE REPORTS

Annual Meeting Plan – Pros and cons of having the Annual meeting in-person or on Zoom were considered. A motion to have the Annual Meeting via Zoom was made by Amy and seconded by Lynn. Motion was unanimously approved. Dee Ann will set up Zoom for the meeting. The Annual Report will be sent out to all members for approval after the meeting.

Secretary Options/Nominating - Eileen Perfrement will do some of the secretarial work. Amy said that no-one else has volunteered. If no-one steps up, then a member of the Leadership Team could take notes when not hosting a meeting. Amy suggested that notes be simplified as to decisions made and actions taken. Ideally, there would be three secretaries.

Prepare for hybrid meetings in fall – In the fall, the Leadership Team should prepare for hybrid meetings. **Francesca will check with Thurston Co. to see what kind of equipment we will need.** We can also **contact the librarian at the college** to see what equipment they use. Liz mentioned that she can share training notes on hybrid meetings with the Leadership Team this summer.

Where do Zoom recordings go? Dee Ann said the meetings are only recorded in case the secretary needs them. Cindy S. may have some ideas on what to do with the recordings.

Clarification on candidacy policy – A concrete proposal by the Leadership Team needs to be in place for the Fall.

Media

Mason Web TV has been generous about covering our meetings. **Question** – should we enter into a formal agreement with Diedrich and offer him a stipend? Should we advertise monthly using our Logo? **Amy will clarify with Mason Web TV the cost of doing a hybrid meeting.**

When doing Zoom, we can send Diedrich the recording. Lynn - we need to come back with a proposal on ways to get our name out. No decision made because we need more facts. We have a Zoom account and should be prepared in the fall to use it.

Thank-you responsibility – Thank-you cards have been sent to the speakers by the secretary taking notes at the meeting.

Board Retreat and Date and Plan

Nancy M. has offered her home for the Retreat. Lynn will send out possible dates to Board Members.

Treasurer's Report – Pat C. -The draft for the annual budget is still in process. It will have a new media category. We currently have a balance of \$6,299. \$3,000 will be paid to National. \$125 could be given to each of the four people who are attending the LWV Conference. We still need a backup person for Pat.

Climate Change Committee – Sherri D.

The Steering Committee will meet on June 9 to make it easier to give direction to where the Climate Change Committee will go in the League.

The **Bright Action Program** gives people ideas on ways to take individual action on climate change. Nancy S. plans to incorporate Bright Action into her meetings at her home. There is no charge for individuals to utilize the Bright Action Website. A platform is already in place on the LWV/Seattle website. Nancy recommends that we look at a website before Fall.

There will be an orientation this summer for new members. An e-mail will be sent out to see whether people want to meet outdoors or via Zoom.
