This year we used our ED Fund to pay for our TRY brochures. We also wrote a grant to buy new tech equipment for hybrid meetings. The state dues have been paid, but the national dues for our 67 members are still outstanding. The bill will be around \$2144. 2022–2023 Annual Report

For a century, women have found a home in the League where they can learn about issues, communicate with a diverse membership, and provide community leadership. Just as our Centennial Project provides an avenue for understanding women throughout the 20 th and 21 st

century (and still ongoing today!), the League has used the suggestions found in various publications that we've studied as a method to try to find common ground among members of our community. All our committees this year have provided members with opportunities to learn and lead by following local government entities and keeping members informed about issues that have an impact on Mason County citizens.

Thanks to a Washington State League of Women Voters Education Fund grant, we began offering hybrid meetings to our membership. Using the technology of a Meeting Owl Camera and a laptop, members can now watch and participate in monthly educational programming, whether in person or via zoom.

- Held Forum for county candidates for Auditor, Clerk and Assessor
- Hosted our world-famous Speed Dating Forum, with 100% turnout of candidates
- Received nationwide coverage by the Associated Press of Speed Dating Forum
- Formulated questions for the candidates at various Neighborhood Meetings
- Set up Voter Registration tables at Allyn Days, Matlock Old Timers Fair,

- YMCA, Forum for County Candidates and Speed Dating with the Candidates
- Visited 10 high school classes at CHOICE, Cedar, Mary M. Knight, North Mason, and SHS
- Registered 15 students and passed out 250 to 300 TRY brochures
- Put together a training packet for League of Women Voters members working at Voter Registration tables
- Distributed "The State We're In" civics textbooks to all Mason County high schools

- Stabilized our membership at 67, with 10 new members
- Engaged 72% of our membership in League of Women Voters' activities
- Held two League 101 orientations for new members
- Printed 400 TRY (They Represent You) brochures for distribution
- Donated over 1,200 menstrual products to CIELO and Turning Pointe as part of a local action against period poverty and stigma
- Authorized a committee to review and recommend updates to organization's Bylaws
