- Alene Griffin, Marsha Waggoner and Marie Bairey also registered voters at the Modesto Art Walk.
- Vote411, with information coordinated by Colleen Norby, remained a reliable source of information about candidates.
- Our Instagram and Facebook pages provided regular updates about registration and voting.

We appreciate the dedication and work of our members and the Voter Service team, who personified the adage, "Democracy is not a spectator sport."

LWVSC Board Meeting Highlights October 2024

The LWVSC Board of Directors met on October 9, 2024, to conduct its regular business. Highlights are below.

- Voter Services activities continue with the general election approaching.
- The national League of Women Voters is implementing structural changes that were adopted in 2018. Beginning January 2025, members will pay dues to the national League, and the national League will disburse funds to the state and local organizations. This change follows a study and a transformational roadmap for a renewed and more effective organization.
- Holiday Fling will be Monday, December 9, at AgSafe in downtown Modesto. More information to come.

LWVC Health Committee Report

Position on Healthcare

The LWVC adopted the LWVUS position introduced in April 1992 and updated in 2016.

- Provide a healthcare system for the U.S. that provides a basic level of quality care for all residents, including behavioral health that is integrated with and achieves parity with the physical care. Cost needs to be affordable to all residents.
- The statement goes into detail as to what services need to be included such as mental healthcare and treatment of addictions. Dental, vision and hearing care are addressed but are of lower in priority.
- The option to purchase alternate services beyond the basic offerings is included in the statement.
- Patient and patient/family driven decisions are to be respected.
- LWV endorses that the plan is financed through general taxes. However, it also discusses finance by private and public sectors.

Position on Mental Health

• In addition to the Mental Health statement included in the overall Healthcare Statement as described above, there is a separate position statement on mental healthcare only.

On October 17, 2024, League of Women Voters of Stanislaus County presented a Pros and Cons session about the California state propositions at the United Methodist Church in downtown Modesto. It proved to be a very clear and organized presentation. In addition, the Voter Service committee provided presentations at MJC on September 30, 2024, and for AAUW at the Oakdale Senior Center on October 10, 2024. These three presentations gave members and the public an opportunity to understand the various propositions and be able to clarify their views in preparation to vote.

The Meet and Learn session also informed participants about resources on the LWV California website for ballot recommendations and pros and cons, including a handout, "Vote with the League, Ballot Recommendations". Other resources available were www.easyvoter.org and ballotpedia.org.

Another strategy was to ask friends who are interested in a deeper understanding of the propositions to study and analyze the pros and cons as a group. A number of these propositions were extremely complicated so a bit of studying might deepen voters' understanding and inform their vote. It was a journey that was made easier by the Meet and Learn session.

Our Meet and Learn for November will be held on November 25, 2024,11:30 a.m., at Gather. Lunch will be served for the total price of \$20.00, thanks to the generosity of Gather and the Endsley Family. Our guest speaker is Modesto Mayor Sue Zwahlen, who will share her plans and goals for 2025.
